Open Letter

Dear Dr. Paine,

Re: Reliance upon David Gibbs Jr.

This letter is to ask you to immediately cease all communications with and all reliance upon Mr. David Gibbs Jr. the attorney and Director of Christian Law Association (CLA) and with Gibbs & Assoc. (OH).

Mr. Gibbs Jr. is not known for his proven experience in spiritual restoration of broken relationships among believers. He has many serious conflicts of interest in the case of the IBLP organization and with Bill Gothard personally, preventing him from offering any integrity to any investigation of the charges and crimes being presented against Gothard and against the IBLP organization. The trail of damage Mr. Gibbs has left in the church of Jesus Christ disqualifies him from being involved in any spiritual oversight or responsibility for advice to any organization that intends to represent the Gospel to the public.

I Timothy 3:7

Dr. Paine, you and your Board of Directors were presented on Jan. 2, 2014 materials that outlined many serious charges against Bill Gothard and your Board supported by 140+ pages of evidence, much testimony, and documentation. It is clear to all that with no response to those charges by Gothard, and with no response from your Board of Directors to those charges against Gothard and against you, and with no evidence of any valid investigation of those same charges by Mr. Gibbs Jr., the charges will stand as published. In the past four months, Gothard nor the Board have indicated any lack of clarity regarding each of the charges, nor have you noted any error in the evidence, testimony and documentation presented. The failure to respond to these serious charges and evidence demonstrates that Mr. Gibbs Jr. is not capable of addressing these charges or assisting with any Report as to their validity or falseness. More critically, it is adequate evidence to demonstrate to the world and any court of law (Romans 13) your personal efforts to cover up sin and gross immorality and protect those perpetrating serious sins against the children of God.

If you can agree with this request in the next seven days, we are asking you to publish a brief letter that you have agreed to this request and you have indeed broken off all communications with, arrangements, contracts and alliances with Mr. David Gibbs Jr. If we have not heard from you by letter, email, fax, or by courier in this period of time, we will conclude you have decided to continue your alliance with this man.

Your response, either way, will be published nationwide and now worldwide along with a careful description of the men Bill Gothard has consistently selected for help when he is being confronted about his unconfessed sins and his abundant disqualifications from the ministry of the Gospel. This summary will include the details of his spiritual condition and his recruitment and reliance upon Dr. John McLario, Dr. John Stancil, and now Dr. David Gibbs Jr. to assist your Board in the cover up of his many sins and his disqualifications while ignoring and failing to deal with the immorality and ungodliness of specific Board members.

This public description and summary of your thought process and your resulting choices will be instructive to the wide church of Jesus Christ in a review of the great lessons of Scripture. The details of the lives of these recruited men and their disqualifications will provide an additional warning to the church as well. In their life time, they will see grandly demonstrated how a "man of God" and his Board of Directors have turned their heart to Egypt for counsel and for resources of horses and chariots against hundreds of warnings by God against doing so.

Bill Gothard's spiritual condition is most serious.

He has abandoned the great riches of God which are in Christ Jesus alone in exchange for his pursuit of the temporary gains he could profit from a needy and unsuspecting audience of God's special children.

He has learned how to garner the praise of men and how to extend the applause of an adoring and worshipping crowd. His addiction has blinded him from understanding the commendation of God is the only prize that counts.

He has violated the rules of the race and is now being disqualified, and while in such great jeopardy, in the face of God's offered mercy and grace for a full confession of sin, he is instead maintaining a stiff neck, by the hypocrisy of a liar searing further his conscience one more day, increasing his walk in darkness.

He has driven away and stoned every minister and prophet which God has sent to him, with disdain disregarding their obedience to Christ, they being willing to take his abuse and wrecking of their lives. Instead he and the Board have consistently gone to Egypt for your horses and chariots, picking the princes of Egypt to become your counselors, time and time again, and again now.

Isaiah and Jeremiah were clear in repeating the Word of the Lord to the rebellious men of Israel:

"Woe to the rebellious children," declares the LORD, "Who execute a plan, but not Mine, and make an alliance, but not of My Spirit, in order to add sin to sin; who proceed down to Egypt without consulting Me, to take refuge in the safety of Pharaoh and to seek shelter in the shadow of Egypt!... Isaiah 30:1-2

This is what the LORD Almighty, the God of Israel, says: 'As my anger and wrath have been poured out on those who lived in Jerusalem, so will my wrath be poured out on you when you go to Egypt. You will be a curse and an object of horror, a curse and an object of reproach; you will never see this place again.' The LORD has spoken to you, O remnant of Judah, "Do not go into Egypt!" You should clearly understand that today I have testified against you. For you have only deceived yourselves; for it is you who sent me to the LORD your God, saying, "Pray for us to the LORD our God; and whatever the LORD our God says, tell us so, and we will do it." So I have told you today, but you have not obeyed the LORD your God, even in whatever He has sent me to tell you....Jeremiah 42:18-21
