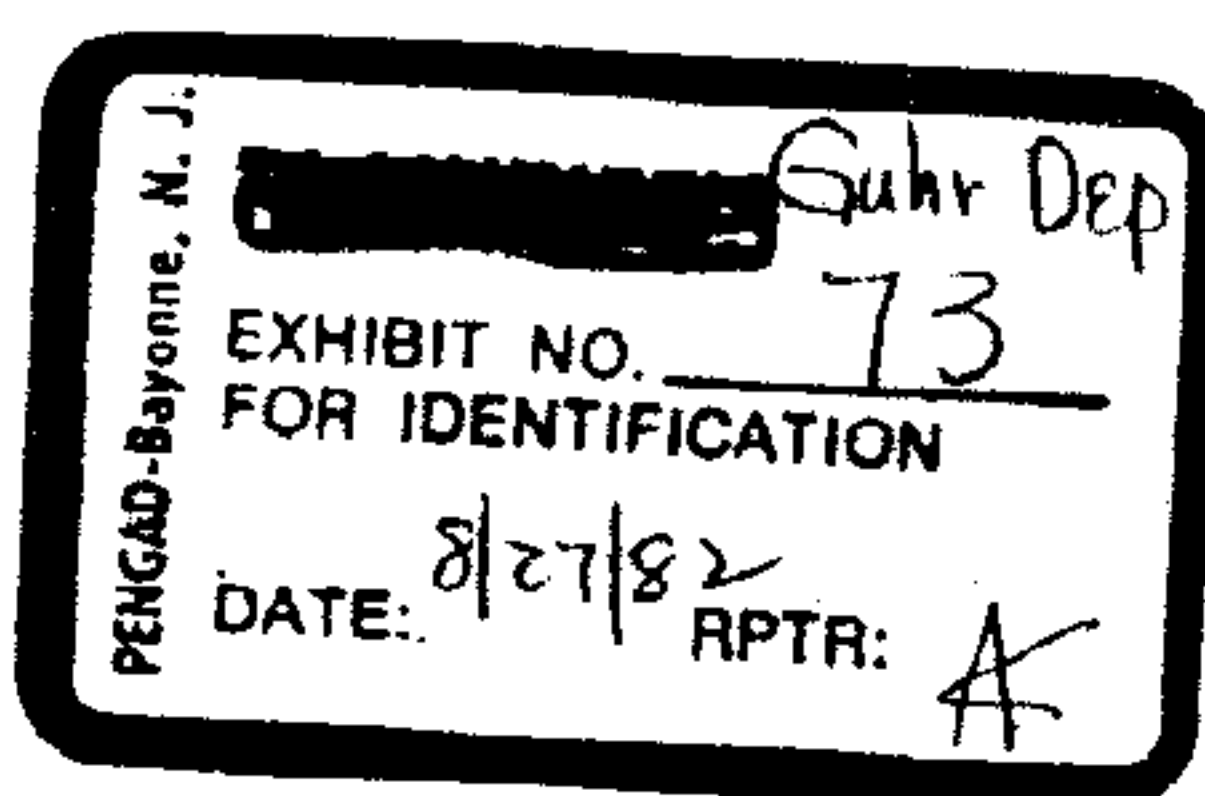

It grieves me that it is necessary to send the enclosed documents to you. However, since you were and will be directly or indirectly involved in its contents, you should be knowledgeable about what is happening.

On September 3, I returned to the office and was given a letter from Mr. Wiebe. The next morning the Lord gave clear direction on how I was to respond to it and the enclosed reply was written.

During the next week, the facts were verified and then it was sent on to Mr. Wiebe. He acknowledged receiving it on September 17. On the following Monday, Mr. Wiebe sent out copies of a previous letter to many individuals reprimanding me for not responding to his original letter.

It is becoming very clear that those who continue agitating are doing so at the expense of the cause of Christ and many who have already been deeply hurt. I believe that the time has come for us to "mark them which cause division."
